(1) Membership Application Form: Return completed application by mail or bring it by in person with payment. If the application is not accepted, payment will be returned. See below for fee schedule.

(2) Sponsorship: The sponsor must be a member in good standing (dues paid up, etc.) for at least one year and be present at one of the readings. If you do not know someone who can sponsor you, come to a meeting (second Tuesday of each month). You will meet many active members who are willing to sponsor new people!

(3) First Reading: The application will be read to the membership at a regular club meeting held at the clubhouse on the second Tuesday of each month at 8:00 p.m. Your presence at this meeting is recommended.

(4) Orientation: Required prior to second reading. This is to thoroughly review the operation of the club, the Standard Operating Procedures and Range Rules, which govern the shooting facilities of the club. If you have any questions, please feel free to ask at this class. Class time notified at the General Meeting. If you cannot make the class, contact the Caretaker to reschedule.

(5) Second Reading: You will be expected to attend the next regular meeting. At that meeting the application will be presented to the members a second time and there will be a vote for acceptance of membership into the club. All individuals who are accepted will then receive membership cards.

(6) Work Participation: You may choose to participate in 4 hours of club related work activity to obtain a refund of the work fee. These activities must be performed during the first year of membership. This fee will be returned after the service of four hours by the use of the Work/Service Form.

Note: Memberships are per calendar year: January – December. Applications approved after October 1st will credit dues (\$115) to the current year *and* the following year, for a total membership period of up to 15 months. Assessment will be billed in the following year.

Assessment: Starting in 2017 through 2022, all members (except Junior members) will be assessed \$40 per year to help fund the Big Bore Range Improvement Project.

Here are the steps to becoming a member of the Lowell Sportsmen's Club:

(1) Membership Application Form: Download from here or pick up at the clubhouse. Return completed application by mail or bring it by in person. Payment must accompany the application, see below for a breakdown of these fees. Payment can be made by cash, check, money order or credit/debit card. If the application is not accepted, payment will be returned.

(2) Sponsorship: The sponsoring member must be a member in good standing (dues paid up, etc.) for at least one year and be present at one of the readings. If you do not know someone who can sponsor you, come to a meeting (second Tuesday of each month). You will meet many active members who are willing to sponsor new people!

(3) First Reading: The application will be read aloud to introduce applicant to the members at a regular club meeting held at the clubhouse on the second Tuesday of each month at 8:00 p.m. Applicant's presence at this meeting is not required, but is recommended.

(4) Orientation: Required prior to second reading. This is to thoroughly review the operation of the club, the Standard Operating Procedures and Range Rules, which govern the shooting facilities of the club. If you have any questions, please feel free to ask at this class. Class time notified at the General Meeting. If you cannot make the class, contact the Caretaker to reschedule.

(5) Second Reading: Applicant will be expected to attend the next regular meeting. At that meeting the application will be presented to the members a second time and there will be a vote for acceptance of membership into the club. All individuals who are accepted will then receive membership cards.

(6) Work Participation: New applicants may choose to participate in four (4) hours of club related work activity to obtain a refund of the one-time work fee. Activities will be detailed at the orientation training. These activities may be performed anytime during the first year of membership. This fee will be returned after the service of four hours by the use of the Work/Service Form.

The membership committee is charged by the executive board with the administration of the procedures outlined above. Hopefully, all questions will be answered in the orientation training, but if not, contact the membership committee chairperson or any other club officers who are listed in the club's newsletter.

Note: Applications approved after October 1st will be credited towards the balance of the current year *and* the following year, for a total membership period of up to 15 months.
